WHEREAS, "Declarant", caused to be filed a Second Amendment to Declaration and Bylaws Creating and Establishing a Plan for Condominium Ownership under Chapter 5311 of the Ohio Revised Code for Stonington Woods Condominium. Said Declaration was filed with the Licking County Recorder's Office on June 9, 1998 and recorded as Instrument No. 199806090021387; and

WHEREAS, Drawings depicting Stonington Woods Condominium Phase III were filed simultaneously with the Second Amendment, filed with the Licking County Recorder's Office on June 9, 1998 and recorded as Instrument No. 199806090021387; and

WHEREAS, "Declarant" has learned that the location of the ingress/egress area for unit numbers 108, 110, 120 and 122 showed an inaccurate access to Phase II of the Stonington Woods Condominium; and

NOW THEREFORE, The proper drawing depicting the location of this ingress/egress area for the above mentioned units is attached hereto and marked as Exhibit "A".


